## 6.5 Application DC/21/00992 – The Pyghtle

The applicant's appeal against BDC's refusal of the application was noted. It was agreed that the Clerk should write a note to the hearing in support of the appeal given that the applicant had made amendments to the proposal requested by the committee and the committee did not agree with BDC's decision to reject the application.

**Action:** Clerk to write a note in support of the appeal.<sup>1</sup>

### 7 PLANNING CONTROL

The committee noted that BDC's enforcement team had not yet contacted the parish council on any action it is taking following reports of work being carried out at The Angel and 13 Polstead Street without listed building consent.

**Action:** Clerk to request an update from BDC.

The committee noted MB's offer to arrange a meeting with BDC's planning team regarding issues relating to the Neighbourhood Plan and the parish council's responses to planning applications. It was agreed that it would be appropriate to discuss this with MB at the parish council meeting immediately following the committee meeting.

#### 8 PLANNING TOGETHER AND COMMUNITY ENGAGEMENT

# 8.1 Twinstead-Bramford power line proposal

MN reported that the planning inspector had decided to increase the area over which visual impacts should be assessed. This was in line with the parish council's response to the consultation on the proposal. It was anticipated that the visual impact consultants would contact the parish council for comment during the process.

# 8.2 Undergrounding

AS reported that he had been in contact with the project team and that the first stage of the undergrounding scheme (between Polstead and Stoke) is expected to go ahead at the end of this year/ start of next year.

### 9 NATURAL ENVIRONMENT

# 9.1 Footpaths

MN reported that the footpath between Scotland Street and Valley Farm is currently impassable due to Suffolk County Council removing it from the cutting schedule in error. SCC had acknowledged the error and confirmed that cutting would resume. MN said he would request that SCC carries this out in the near future given the condition of the path.

**Action:** MN to continue correspondence with SCC on this matter.

#### 9.2 The Downs

AS reported that (i) There is an opportunity to create a wildflower area above the path on The Downs; (ii) Grass cuts were being carried out on The Downs too frequently for an area of this

kind and that the slope was being cut using a ride-on mower which raised potential safety considerations.

Actions: MN and AS to draw up a management plan for The Downs.

Clerk to contact the grasscutting contractor telling him to stop using a ride on mower to cut the slope and that the parish council would provide him with a copy of the management plan for The Downs that would take this into account.
