8 PLANNING TOGETHER AND COMMUNITY ENGAGEMENT

8.1 Boxted Bridge

MN reported that the head of Essex CC Highways would be visiting the bridge in the near future and he would be attending.

8.2 National Grid Bramford-Twinstead powerline strengthening proposal

MN reported that local parish councils had become aware that new technology developed by an American company could enable a significant increase in power supply without the need to install additional pylons.

Action: MN and SG to investigate whether this technology could potentially be used in this project, including given timescales involved, and any NG involvement in the American company.

MN reported that he had been in contact with BDC's chairman on a number of matters related to NG's proposal including location of the sealing end compound.

8.3 Tree refuse – Sudbury Road

It was noted that tree refuse outside a property on Sudbury Road had not been cleared.

Action: MN and FG to visit the householder to request removal.

10 PLANNING AND ENVIRONMENT MATTERS ARISING

MN requested that correspondence from BDC on a call for land to help support nature recovery be considered at the next planning and environment committee. This was considered appropriate subject to agreement at the parish council meeting following the committee meeting.

It was noted that tree removal works had taken place outside the One School in an area where there are no Tree Preservation Orders.

Action: Clerk to write to the school asking if there are any plans to replace the trees and noting that there are no TPOs on them.

It was noted that BDC had launched a call for sites as part of its JLP development and that this was an agenda item on the parish council meeting following the committee meeting.
